The ACC is made up of individuals residing on each street of Phase I – these are also the neighborhood watch reps for those corresponding streets. To maintain the covenants, the ACC Committee will make random checks of the neighborhood as well as accept complaints from residents. Letters of compliance will be placed in residents mailboxes for any infractions found.

If you want to make any changes to the exterior of your home, an approval must be received prior to any work or additions/changes being done. To do so, please complete the approval form (located on the Yahoo group or get one from a board member) & return to Sarah Pennington. Voting amongst the ACC members will take place and the committee will notify you of the voting results within 2 weeks & an official letter will be placed in your mailbox with either approval or denial of request.

The ACC also needs help – if you see something that needs addressing, you can either let your street rep know or follow these streets yourself:

- Residents can complete a Complaint Form (located on the Yahoo Group or get one from a board member) & email it to Sarah Pennington or the committee will note issues by making neighborhood inspections.

- The committee will issue letters to residents with items to be fixed to comply with the stated bylaws.

The board, ACC and Neighborhood Watch Committee does recognize that there are some outstanding issues of items listed in this newsletter. We would like you to know that we are working on them but it does take time to work through all the necessary processes. Clabber Creek is designed to be a single family home neighborhood and all of us involved are working our hardest to keep it that way but we need your help in reporting incidents and any violations to the covenants that we are all supposed to be following as residents of the neighborhood.

What is the ACC and Neighborhood Watch?

The ACC is the Architectural Compliance Committee whose job is to help uphold the covenants set in place by the POA. These include maintaining outside spaces of the neighborhood as well as approving any requests from residents for making changes to the exteriors of their homes.

The Neighborhood Watch is set in place to help with the security of the neighborhood. Each street in Phase I has a street representative that is the main contact for any security related issues. These issues are then relayed onto Sandra Ware, the police contact, and then forwarded to the police department.

What can you do to help?

- Be a mindful resident, follow the covenants in place (can't find your copy of the covenants? They are posted on the yahoo group)
- If there is an issue that you see, bring it up with a board member or street representative (all contact info listed here in the newsletter)
- Contact the police at the non emergency number for any issues that are needing police assistance 587-3555... such as noise issues after 11pm, parking the wrong way on the street, parties, etc.

Just a Few Reminders:

- **Habitual parking on the street is prohibited** – this is a big one!! Especially with summer and the kids being outside more!
- Keep lawn and garden areas free of weeds and attractive.
- Trash containers, recycle containers and yard waste bags are to be stored out of sight.
- Lawns need to be edged along the sidewalk.
- Be sure to have guests park the right way on the street
- It is your responsibility to make sure your guests adhere to these rules as well

July 4th Parade

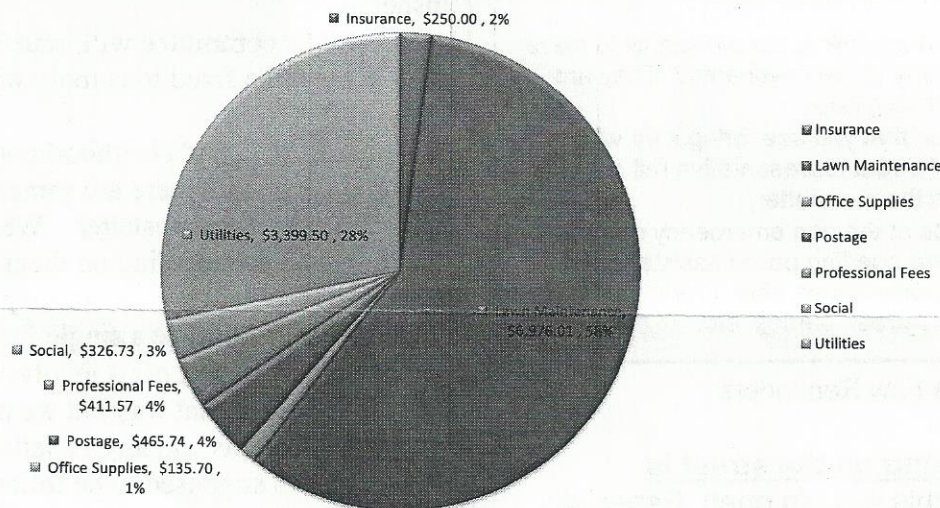
